- 2. CE certificate not submitted online.But submitted offline. CE certificate is on Respironics Inc.
- 3. As seen from the manufacture's authorization Form dt.14.06.2016 (Page No.44).it is stated that M/s Philips India Ltd are established and reputed manufacturers of various medical equipment having factories at various contries and have authorised M/s Medifocus India Pvt Ltd, Chennai in bid, negotiate conclude the contract etc.vide as on tender notice.
- 4. Whereas in support and claim of M/s Philips India Ltd as "Manufacturer", the certificate of Registration from BSI is furnished (Page No.40-43), wherein it is clearly mentioned the scope / activities as "The Marketing, Sales, Installation Service and Clinical Support for different Medical Equipment.
